Dear Representative Bacon:

The Society of Former Special Agents of the Federal Bureau of Investigation offers its formal endorsement of the LEOSA REFORM ACT. Our Society has been in existence since 1937 and is the oldest and largest membership organization for former federal law enforcement officers. We have approximately 8,500 members and 120 active Chapters throughout the United States. Our members are keenly interested in continuing to help keep America safe and we believe this legislation will assist greatly in that endeavor. We are prepared to work diligently towards the successful passage of this legislation.

As you are very much aware, the bipartisan Law Enforcement Officers Safety Act (LEOSA) was enacted into law in 2004. The federal law established guidelines allowing experienced retired or off-duty officers who maintain proper training to obtain certification allowing him or her to carry concealed firearms. Essentially, the Act's purpose was to create a shared national policy between states allowing officers to carry their firearms wherever they are, granted they are qualified and have received appropriate credentials. Since then, two separate amendments have provided meaningful progress, but there are still needed reforms which would be implemented by the legislation you are introducing.


This legislation provides six concrete reforms for the LEOSA: (1) Allowing those carrying pursuant to LEOSA to carry on a Gun Free School Zone (GFSZ); (2) allowing them to carry on state, local and private property, including common carriers, otherwise open to the public; (3) allowing carry in a national park; (4) allowing retired officers to carry any magazine which is not prohibited by federal law; (5) reforming qualification standards to alleviate undue burdens for those carrying pursuant to LEOSA; and, (6) allowing carry in certain Federal civilian public access facilities (e.g. US Post Offices and Social Security offices, etc.).

Those carrying in accordance to LEOSA are men and women who have faithfully served and protected our communities. A primary benefit of LEOSA is providing additional safety for the communities where the officers and retired officers live and visit. The enactment of this proposed legislation will better allow our members and other law enforcement officers to respond to active shooter situations in schools, on common carriers, in national parks, and in

other public and private locations. The before-mentioned reforms will safeguard the rights of our retired and off-duty officers, ensure that they are best equipped to protect us all, and significantly enhance public safety.
